## **BIRTHDAY HIGHLIGHTS FOR CAPRICORN**

**Happy Birthday, Capricorn!** Your totem is known as the Mountain Goat, the third earth sign, fourth Cardinal sign of the Zodiac and the natural occupant of the 10<sup>th</sup> House of career, status in life, ambition, authority, father figures, bosses, government, maturity, recognition of achievement and the path to success. Saturn rules your sign and plays a lead role in attracting you to a variety of challenges in matters of fame, reputation and influence. Most of you desire to improve yourself both mentally and physically on your quest to accomplish your dreams. My take on many Capricorns is that they fell out of the crib and into the job market embracing work as a way of life. Your sign rules the bones, hair, joints, knees, skeletal system, skin, and teeth. Colors affiliated with your sign are black, dark blue, most deep shades, gray, navy, maroon, slate, evergreen, and brown. This year the Sun enters your sign on December 21 at 11:28 AM EST a date which also coincides with the winter solstice; and leaves on January 19 at 10:10 PM EST. **Some of the material in the following section also refers to individuals with Capricorn on the Ascendant.**

For organization-minded Capricorns the year ahead is tailor made to stir up your 11<sup>th</sup> House of groups, associates, friends, goals, wishes, dreams and humanitarian endeavors. **Jupiter in Scorpio** occupies this house through November 9, 2018 meaning you could meet new people, spend more time with favorite connections or members of associations whose values you share or join groups that have similar philosophical interests. Maybe your expertise is just what the group needs to invigorate leadership, troubleshoot problem areas or reframe direction in 2018. Do work on personal and professional goals during this cycle. Desired funding comes through for many. **After November 10 you have Jupiter in Sagittarius occupying your solar 12<sup>th</sup> House** of seclusion, behind-the-scenes activity, planning for your future, secrets, trysts, hospital visiting, charity, mystical experiences, self-imposed limitations and metaphysical pursuits. This birthday year finds your signature planet, **Saturn, beginning a new cycle in its home sign Capricorn in your solar 1<sup>st</sup> House of action, assertiveness, self, physical appearance, innovation, passion, responsibility and self-promotion.** If you have other Capricorn planets as well, the cycle is more activated than usual, especially if your birthday falls December 22-January 2. You will feel a shift in responsibility that covers several scenarios; for some it may mean more responsibility than usual while others get some extra help to balance the load. If health issues have been around, you will see medical professionals who help you find solutions; teeth could be a problem; or possibly matters connected to your bone structure. The time is excellent for managing goals and learning efficient techniques - few call you lazy, but some may say you stay too long on one specific task. Find new social outlets and

exercise programs to release tension that has been building. If you have been depressed or deal with those who have psychological challenges, step back and take stock of what is working and what is not. **Mars in Aquarius will give you a run for your money for about 5 months in 2018 in your solar 2<sup>nd</sup> House of income, expenses, assets and personal values beginning May 16 through August 12. Then Mars will be Rx in Capricorn, goes direct on August 27<sup>th</sup> and moves back to Aquarius from September 10 - November 15.**

That is a lot of Mars in a single sign considering it usually spends 2 or less months moving through a sign. Take care of financial matters, exert patience in taking inventory of what is essential and what must go. Embrace personal principles when they are challenged. Do not be sold a bill of goods that does not fit your ideals.

**Uranus in Aries is retrograde as your birthday cycle begins until January 2<sup>nd</sup> and most affects Capricorns born January 13-20 through May 15 in your solar 4<sup>th</sup> house**

of home and family where it has been actively shaking up the status quo of personal relationships via creating unexpected events at home base, generating unplanned visits from relatives, bringing new babies into the family and disrupting set routines. Many Capricorns or those with Capricorn rising saw how the people or conditions of your 4<sup>th</sup> House played out and testy conversations taxed your time due to clashing opinions. Avoid arguing during holiday visits, reinforce security systems and keep a close watch around January 2. Yoga and meditation may help you maintain better health. When Uranus moves to Taurus on May 15, your solar 5<sup>th</sup> House of children, entertainment, lovers, recreation, risk, romance, speculation and sports is the center of attention for the next 7 years. Any changes you make will last a long time even though the rhythm of Taurus has a different, slower and more stubborn pace than it has been in fiery Aries. If you are not in a relationship, Uranus in this house can mean a variety of romantic connections, a true example of what I wrote about in the article "Runaway Love." Check your chart if you have this new energy dawning in your 5<sup>th</sup> House. I can just see the mailbag content in the coming years. Uranus frequently affects weather patterns or shakes up the status quo related to specific themes. Be prepared. **Neptune in Pisces contacts your Sun if born January 1-6 in a favorable aspect in your 3<sup>rd</sup> House of communication, the mind and mental outlook, as well as education, technology, siblings, neighborhoods and transportation. Perhaps you'll find inspiration in dealing with mental strain as you gain insight into communicating with residents, family members, educators, those involved in community projects and vehicles.** Be sure to look over any contracts or legal papers that affect you this year. Neptune can contribute to fogging out when you most need to pay attention to details. You are usually very tuned in but if Neptune is in aspect, it may possibly create conflicts by causing you to ignore facts. Tap into your intuition and treasure your gift - it works well when you use it. With Neptune in positive aspect, you may have an uncanny way of knowing what is going to happen before it does. You may also be reading or writing more than usual with an insightful tone and inspired mind. Avoid purchasing a property in a flood zone if you're moving or investing in property. Take time to relax and unwind if your daily routine needs balance from a steady diet of stress. **Pluto travels only 3-4 degrees a year, half of it spent in retrograde motion.** If you were born January 7-13, you feel the deep level transformations more than others this year. Regeneration could be just what you need in body, mind and spirit. Where have you felt stuck? Now is the time to break away

from the rut. “I’m too busy” is often your go-to excuse. **Pluto in Capricorn in your solar 1<sup>st</sup> House reminds you of what you have been repressing and especially if it contacts any planet in the 1<sup>st</sup> House.** Courage and assertiveness lead you toward power goals and may have helped you land a recent authoritative position or bonus. **If you know your Ascendant sign, look for the house where Pluto transits to address the tension that is calling for action in your life.** Some of you hesitate to delegate authority by controlling the work projects - you make it harder on yourself and then those who work with you can’t grow and you don’t have a chance to experience down time. If Pluto is near your Sun this year, go with the flow and assimilate major changes. You’ll feel lighter as your heart experiences joy.

**The final two eclipses of 2017 are winding down from the intensity they played in your chart. The last full Moon eclipse fell on August 7 in Aquarius in your solar 2<sup>nd</sup> House of personal assets, income and material holdings influencing changes in your financial picture that range from minor setbacks due to unexpected repairs or expenses, to major shifts due to a job change or from company mergers, layoffs or downsizing.** Capricorn, be sure to review career or retirement plans, your budget and current responsibilities. If you received an unexpected windfall or gift, pay it forward to keep the kind spirit going. **The last Solar Eclipse of 2017 occurred on August 21<sup>st</sup> in Leo in your solar 8<sup>th</sup> House reflecting much of what you dealt with in February 2017 and possibly closing the door on irritating conditions you have wanted to resolve.** If you have pared down debt or refinanced your mortgage, your credit score has probably improved, and your mind is at ease with the freedom from the financial tension. A possible outcome is paying off a mortgage or selling your home to buy a new one. Keep records up to date and shop for the best possible financial terms. Minimize stress to keep your blood pressure under control. In 2018 a total of 5 eclipses affects you in three houses. **The first lunar eclipse of 2018 takes up residence in Leo on January 31<sup>st</sup> in your solar 8<sup>th</sup> House of joint finances, money you owe, new income streams, mortgage and estate matters, your depth perception and psyche, birth, sex, death and taxes.** Lunar eclipses are Full Moons with extra energy and drama. **You could be dealing with deep-level decisions due to incidents or occurrences that come up out of the blue. Don’t worry, you can handle what pops up since the eclipse divulges important information about others and their motives.** You’ll be in an adjustment mode through mid-2019 with additional eclipses occurring here over the next 18 months. Focus on what you’re shedding - be it people or property. **The first solar eclipse of 2018 occurs two weeks later on February 15 in analytical Aquarius in your solar 2<sup>nd</sup> House of money you earn, assets, income generating options, self-development and material goods.** You will be working on solutions to income shortage, too many unanticipated expenses, cutting the fat related to budget matters and taking a good look at your salary. Stay at it so that when the next Aquarius eclipse occurs, you will have made reasonable headway. Reject implausible expectations and stick to your budget. Consider whether a part-time job will help your financial picture or apply for a better paying one. **On July 12<sup>th</sup> the solar eclipse sign shifts to Cancer and occupies your 7<sup>th</sup> House of relationships, partners of all types, roommates, the public, advisors, consultants, and collaborators. Entrance into this sign is a teaser for what is to come next year. What’s the quality of your current relationships?** You’ll be hearing about moves either into your space, out of your space or to another city. ## **PLANET ACTIVITY FROM DECEMBER 21-JANUARY 19**

Look what is going on with the planets around the holiday season! **Mercury goes direct in mid-Sagittarius at 8:51 PM on the 22<sup>nd</sup> of December** and moves into Capricorn on January 12<sup>th</sup> where it resides for the remainder of the Capricorn cycle. Many readers reported their encounters with retrograde Mercury: canceled meetings, medical tests that were scheduled, canceled and rescheduled, lost jewelry, vehicles that acted up and had to be towed or serviced; playing telephone tag with callers, the need to return purchases when problems were uncovered upon closer examination, and documents that needed a signature during the Rx period even though the timing was off. **Venus wraps up in Sagittarius on December 25<sup>th</sup>** giving late-born Sagittarians a boost in the love department and moves to Capricorn through January 17. **Mars is in Scorpio** throughout this cycle and lends extra passion and spirit to Scorpios - just what they need to liven the social events of the season. Be careful of temper tantrums or bouts of impatience. Those of you with compatible water and earth planets could find yourself in a highly romantic cycle (Cancer, Pisces, Virgo and Capricorns). **Jupiter in Scorpio most affects you if born November 5-12 and shows an increase in your overall prosperity, unexpected funds, inheritance matters, relationships with family members, improved business cycles and spiritual**

**gatherings.** Jupiter here will also benefit Cancers, Virgos, Capricorns and Pisces born with planets at 14-22 degrees. Jupiter is harmoniously relating to both Neptune in Pisces and Pluto in Capricorn now adding a calmer and artistic vibration (Neptune) and/or attunement to the business realm including mission, vision and long-term plans (Pluto). Leo, Aquarius and Taurus members are wise to keep an eye out for challenging circumstances, especially if born with planets at these degrees. **Saturn moved into Capricorn on December 19<sup>th</sup> ending a 2-1/2-year stint in Sagittarius. Now Saturn most affects Capricorns born December 22-24 this month as well earth signs Taurus and Virgo benefitting from harmonious aspects along with water signs Scorpio and Pisces born 0-4 degrees of their signs. Saturn energy intensifies for cardinal signs Aries, Cancer and Libra born the first 4 degrees of the sign, illuminating situations that need work.** Look for evidence of tearing down existing structures to make way for calmer, cooler heads making decisions. This shift is true on a global level where leaders want to restore order, make sound decisions, plan for stronger economic strategies and make the world a safer place. Look for those who come to power during the Saturn in Capricorn years (2018-20) with strong, honest leadership qualities capable of initiating positive unification of countries and policies that work for the greatest good of all. Avoid embracing movements that are cold and calculating and show disregard for humanity. On a personal level, acknowledge strengths as you set goals and manage time and long-term goals. Use your talent wisely and develop depth perception to help you solve problems. Enjoy the current favorable aspects to the outer planets Neptune and Pluto. Create meaningful change. **Uranus in Aries most affects Aries born April 13-15 and members of Cancer, Libra and Capricorn born around 24 degrees of their signs.** Get ready because Uranus has been retrograde in motion since August 2<sup>nd</sup> and goes direct on January 2. This planet makes a lot of noise. While in the current position Uranus makes a strong statement regarding shifts in direction especially for those born around the affected dates. Opportunities for new beginnings abound so look for them and act in your best interests. Think about what you have started and consider the next few months to be a closing exercise while a new door is ready to open in the spring and beyond. Yes, there will be a few bumps and shocks and unplanned events - that's Uranus - yet many of you are ready for a new adventure. Seek breakthroughs for medical dilemmas, and donate time or funds to help those less fortunate. **The Cancer Full Moon** occurs on January 1<sup>st</sup> at 9:25 PM followed 12 hours later by **Uranus going direct on January 2 at 9:13 AM EST**, a day that could be volatile, surprising and erratic depending on the layout of your chart. **Transiting Pluto in Capricorn occupies the 18<sup>th</sup> and 19<sup>th</sup> degrees of the sign during this cycle and most affects Capricorns born January 7-10 and all cardinal signs with planets at 18-19 degrees including where you have your Ascendant.** Pluto's known as a slow but insidious planet that has a way of bringing to light any conditions that need regeneration or are out of control: toxic self-talk, people, addictions, and dead energy. Identify those secrets you have kept buried and acknowledge them so that you can move forward. Amplify the quality of your life. Pluto helps you let go of angst if you develop clear insight and probe the depths of your inner world. Chiron the Wounded Healer is **direct now in Pisces and most affects those born March 14-17** who tap into the recesses of their sensitive psyches and work on difficult and often

deeply buried personal matters. By searching for the truth, acknowledging pain and analyzing facts, you understand the action plan that is unfolding. Welcome to the real world and respect for the quality of your life. Tap into your intuitive your sense of intuition. You, and all readers, have the tools to bring optimism into your life in the New Year.

**Prince Harry and Meghan Markle:** The Royal Family announced the engagement of this enterprising couple on November 27. Shortly thereafter the couple disclosed the wedding will take place on Saturday, May 19 at St. George's Chapel at Windsor Castle breaking with the royal tradition of scheduling weddings on weekdays rather than weekends. What makes this couple click? What lies ahead for this dynamic duo? Harry is a Virgo born September 15 with a late Leo Ascendant, Juno, Vesta and Mercury in Virgo, the Moon in Taurus, Venus in Libra, several planets in Sagittarius including Uranus on Mars and a Jupiter/Part of Fortune conjunction in Capricorn. Meghan was born on August 4, a Leo, in the sign before Harry's. Her birthtime in Canoga Park, CA, gives her Cancer rising at the degree of the U.S. Mercury, a significant position for attracting the attention of the news media, and a connection that is important when looking at the union of a couple from different countries. Transiting planets in her chart grabbed the attention of the U.S. media. The engagement was announced when Uranus was moving through her 10<sup>th</sup> House of status quo while harshly hitting her Cancer Ascendant. Meghan also has Mars in Cancer conjunct the U.S. Sun. Her chart holds 5 Leo planets, two in Virgo, 6 in Libra, including her Moon, two in Scorpio, Neptune in Sagittarius and Chiron in Taurus on Harry's Ceres in that sign, a configuration which will factor into their decisions to support causes involving children

and family life. The chart patterns show they most likely knew each other in previous lifetimes. Five of Meghan's planets fall in Harry's 12<sup>th</sup> House of the past; most of the others fall in Harry's 1<sup>st</sup> through 4<sup>th</sup> Houses including her Venus in Virgo in his 1<sup>st</sup> House. She is always on his mind. Harry's North Node (where he is going in this lifetime) in Gemini (a sign affiliated with the UK and London) falls on Meghan's Part of Fortune showing their intertwined destiny that will take them on many exciting adventures. She already feels at home in his country and enjoys socializing, and with all the Leo in her chart, the pageantry affiliated with ceremony. She will have many opportunities to bond with the public in a variety of countries representing diverse causes. Let's wish the happy couple an abundance of joy as they embrace their new life together.

## READERS' CORNER

I so much enjoy your comments on articles in this newsletter and the feedback you send. Thank you for your loyalty. I appreciate the continued interest you show in these topics and your desire for more business and workplace solutions. Here's what came in this month.

**Q.** My only brother shocked my parents and me by not coming home for Thanksgiving. He last visited in September. Our parents informed us that they were going to retire in the next year or so and planned to put their large, 5-bedroom home on the market in the spring, so they could buy a new, smaller home and settle on it before they retire. My brother did not take the news well and said that our parents were robbing us of our inheritance, told us what the home is currently worth (he tracks the value regularly), and sulked for the remainder of the visit. Neither of us lives in our parents' home. I see nothing wrong with them selling it. A few days before Thanksgiving my brother called to say he would not be joining us for the holiday saying their decision to sell the family home shows that they don't really care about our financial future. What is going on in his chart that he is reacting this way? Thank you.

**A.** Your brother is a Sagittarius born with Saturn in Sagittarius. In the timeframe you described, he was experiencing his first Saturn return which occurs between the ages of 28-30 depending on the degree of Saturn in the natal chart (a milestone interlude in a person's life). He was also born with Uranus in Sagittarius very close to his Saturn position. His natal Mercury (mental attitude) in late Scorpio received a hard blast from the August 21 Solar eclipse in Leo, while his Moon in late Aries has the company of Uranus in Aries transiting and shaking up the security in his world. Does your brother talk about what is going on in his life? Perhaps he has not discussed the extent of the difficulties or challenges he has been experiencing during the last two years that may revolve around his career, relationships and life goals. With his combination of natal planets in relation to the movement of outer planets, he has been feeling disruption, stifled in goal achievement and possibly some depression, and that is why he is reacting so strongly to your parents' upcoming changes instead of dealing with changes that are important for his own personal growth. You don't know enough about what your brother may be experiencing other than his objections to the sale of the family home, which is their choice and makes sense with the plans they are developing. Encourage him to talk about what is happening in his life and to seek outside advice in processing change that he is having difficulty assimilating. Be glad your parents are making wise moves to lighten their load in the future.

**Q.** I have been reading your newsletter for the last 12 years and gain a lot of insight from information you share. I am a Capricorn born December 30. In November I received a generous salary increase for my work performance and this month I received a \$5,000 Christmas bonus which is far more than I have ever received in the past.
