The second solar eclipse of 2022 occurred on October 25, 2022 at 2° Scorpio 00' and fell in your solar 8th House of joint income and savings, debt load, taxes, karmic matters, psychological conditions, mental depth, and how you discharge duties related to managing other people's money like estates or wills. You and your partner may have experienced revitalized financial windfalls or one or both of you may have changed jobs. READERS CORNER

Last month's newsletter stimulated discussion over long-term transits of outer planets. Readers were very positive regarding the clarification that explained why planets stay in certain houses for long lengths of time. Thanks to all who commented. This month we'll look at aspects unfolding in the chart of an early born Aries who has several planets affected by shifting signs of current planets. The subject of moving is also addressed. Hope you see yourself and others in a new light. Related topics may appear in future newsletters.

Q. I am an Aries and was born March 21. I have been very restless over the past two years, have considered moving but have not felt drawn to any particular place. I have a good job but sometimes feel bored. I have not started job hunting yet. What do you see in my chart? Can you help me decide where to move?

A. I am going to address your chart first since you are an Aries. Please note that as Aries dawns this year, the Sun, New Moon, Jupiter, Chiron, Mercury, and Vesta are in Aries. You have Pisces on the Ascendant and that puts each of the transiting planets in your second house along with your natal Sun. No wonder you are restless. Mars is moving to Cancer in your natal 5th house on the 26th which creates a hard aspect to your Aries Sun. And your 2nd house of income, assets, and self-development will receive the year's first solar eclipse on April 20th in Aries that connects to natal Mercury in Aries. Neptune in Pisces is in hard aspect to your 4th house natal Moon in Gemini. And Uranus in Taurus has been in your natal 3rd house since 2018 giving you an unsettled feeling as though something is about to happen in your neighborhood or creating interference to how you are processing information mentally - maybe worrying too much without knowing what is driving the worries. I would do nothing until you have had a thorough consultation to sort out priorities and identify what appeals to you and what does not among the array of choices that are evolving. As for giving advice on where to move, I never tell anyone where to move. No one but you can determine whether a location appeals to you or makes you feel secure, at peace, at home, or enthusiastic about building a new life.

I recommend using Astrocartography before moving, a facet of astrology that looks at the effect of relocation on the natal chart. So many variables exist related to why you might want to move that I can address them only generally in this space. First of all it is important to visit cities that interest you. You probably won't find out much about a city if you are passing through or are on a business trip and have numerous obligations that interfere with how much you can learn about the location. If you like what you see then go back when you can take your time and learn more about it. I recommend spreading out the location of cities that interest you - if you concentrate only on one geographical location, such as the east coast, you will not see much variation in how your planets respond because the longitude and latitude make a difference, and when they don't change much neither does your life. Sometimes the same two or three planets vie for a position in locations near the same latitude and longitude even though the cities are different. The rule of thumb is to go at least 300 miles away from your current location yet that narrow mileage can be misleading when the aspects or visibility of planets are not significant. For example, your Ascendant may change by a degree or so only. If life is dull in your current location, it is not going to change much within that 300-mile radius, and you probably don't belong there. Of course if you go somewhere for the first time and really feel good about everything you see, that might be

one to explore. When I work with clients I recommend that they select at least three cities they like, and we go from there. If you have never been to these places before it is doubtful that I would recommend living there. You have to get a feel for the environment. You can determine links with cities or states without visiting, but living there is a big step and requires more depth of exploration. Generally, if you are a water sign and find a water sign city or one with strong connections to your chart, you are off to a good start. The same compatibility applies to fire, earth and air signs because the environment feels natural to you. You may even be attracted to a state that has other compatible elements to add further connection and confirmation for your relocation choice.

I hope this information is helpful to you and that you take the time to set priorities. Sort out conditions that are affecting your life. Once you do that you can schedule an appointment for relocating if that is your choice. I would be happy to work with you.
